One major outcome is a new organisational structure implemented in early 2020.


As part of these changes the EMRC has introduced Teams, replacing the former Directorate structure.

# 6. HOW IS IT FOGOing?

play in the forthcoming rollout of FOGO in Perth's and the City of Bayswater – are rolling out FOGO in 2020, requiring intensive community education programs within their areas. Bin tagging is an important tool used to gather information and insights into how people are currently recycling their waste.

One of the measures of success of FOGO – Food Organics Garden

Organics - is residents' awareness of the need to separate WALGA Waste and Recycling Manager Rebecca Brown, who recyclables from other waste in the home. Physically checking a sample of bins in a specific area is a valuable indicator of residents' recycling practices and also provides a mechanism to provide individual feedback to improve their efforts at home. Bin tagging is part of the wider rollout of the three-bin FOGO system being implemented across the Perth metropolitan region, with every council encouraged to adopt the system by 2025.

led the EMRC session, commented: "Everyone working together to ensure they put the right items in the right bin is highly effective at helping create understanding around the importance of correct waste separation. Our bin taggers have an important part to play in this process."

### How does bin tagging work?

Community Waste Education Officers work in pairs to make visual inspections of kerbside bin contents just before collection. They check for contamination - items in the wrong bin - such as recyclables in the general waste bin, or contamination in the FOGO and recycling bins. Following inspection, bin taggers place a 'happy' or 'sad' face tag on the handle of the bin which provides feedback for residents about how they waste if they are given the correct information." are using the bins and where necessary, provides encouragement to make improvements. The data gathered enables better recycling, reduces processing costs and results in less waste being sent to landfill. After the introduction of FOGO, the intended results will be high quality, clean compost.

"Bin taggers are not interested in collecting personal information," continued Rebecca. "Officers will not be 'rummaging' through the bins. Rather they will be aiming to gain a general overview of how households are sorting waste.

"Similar programs in other local government areas have shown most residents are keen to do the right thing when it comes to separating their
