
We're extending a warm welcome to Mindarie Regional Council as a member of the Green Deal Alliance (GDA). Established by the EMRC in October 2021, the GDA aims to provide pathways to increased resource recovery infrastructure in the Perth/Peel region and across WA's south west, creating meaningful jobs, building community resilience and protection for our natural ecosystems.

Red Hill Waste Management Facility site manager Tanya Beinhauer and I were pleased to host Hon Ken Wyatt, Federal Member for Hasluck, during his recent visit to the Red Hill Waste Management Facility. We discussed various issues including the EMRC's Food Waste for Healthy Soils Fund application for a large-scale on-site FOGO processing facility, highlighting the importance of joint investment by industry, state and federal governments.

The fund, comprising \$57 million, is aimed at supporting the diversion of nutrient-rich household and commercial organic waste from landfill to soils by building new or enhancing existing organic waste processing infrastructure. The principle is 1:1:1 funding, in its application EMRC proposed 2/3 by industry (EMRC), matched by 1/6 from state and 1/6 from federal governments.

2 EMRC Passes Major FOGO Milestone

February 2022 is a highly significant date for the EMRC's Food Organics Garden Organics (FOGO) Recovery Strategy with the first deliveries of 2,000m³ of FOGO-derived topsoil and soil conditioner products for a major urban infrastructure project.

Following the EMRC's successful negotiations to supply materials to Downer, the Public Transport Authority's delivery partner for METRONET's Denny Avenue Level Crossing Removal project, the first loads were delivered on Thursday, 10 February 2022. The FOGO-derived base material is sourced from the EMRC's Red Hill Waste Management Facility. Other additives added off-site by EMRC partners to achieve fit-for-purpose specifications.

Prior to the first deliveries, samples of FOGO-derived soil conditioner and topsoil native mix were provided by the EMRC and accepted by the PTA's Landscape Project Engineer, meeting a key project requirement of a fit for purpose, low phosphorus native mix, compliant with Australian Standard AS 4454 and AS 4419. The Sustainability Waste Alliance (SWA) will monitor the performance of the products to support the development of the model specification for significant future road and rail projects.

Over the past 18 months, the Red Hill Waste Management Facility has been processing FOGO material for member Councils the Town of Bassendean and the City of Bayswater, and building capability for FOGO receipt, conditioning, pasteurisation and maturation by deploying controlled aerobic composting technology.

EMRC CEO Marcus Geisler said, 'FOGO collection from every household is a key component of the State Waste

Avoidance and Resource Recovery (WARR) 2030 Strategy, prompting councils to move towards building in-house processing capability and expanding community owned infrastructure as well as optimising control at all stages of resource recovery being education, engagement, collection, processing and sustainable end markets.

'This expected extra capacity will in turn enable the State Government's Office of Major Transport Infrastructure Delivery (OMTID) and the SWA to move towards 100% recycled content by using soil conditioner and compost in their projects, which includes METRONET's Denny Avenue Level Crossing Removal project.'

Green Deal Alliance (GDA) Chair Andonis Missikos said, 'The EMRC's leadership is exemplary as it's driving the acceleration of the Circular Economy in WA as per the requirements of the state and federal government's policies for waste reform. The SWA's role through its Innovation-Hub is bringing the 'Best Minds together from all sectors, accelerating the removal of obstacles in the supply chain between willing buyers and suppliers. The move "TOWARDS 100" policy approaches driven by OMTID's Vision on its 'Big Build' Projects augurs well for the Strategic Co-Investment Goals of SWA through the GDA.

3 EMRC's Green Deal Alliance Welcomes a New Member

The Green Deal Alliance (GDA) has welcomed Mindarie Regional Council on board as a new member.



The EMRC established the GDA in October 2021 with two State Government entities: the Office of Major Transport Infrastructure Delivery (OMTID) and the Sustainability Waste Alliance (SWA). OMTID was established to streamline the delivery of major infrastructure projects (road and rail) valued at more than \$100 million. Several procurement processes, including for METRONET projects, are being fast-tracked to assist the post-pandemic economic recovery. The Sustainability Waste Alliance (SWA) is a unique stakeholder alliance established in 2020 by OMTID to deliver on the commitment made to the Department of Water and Environmental Regulation (DWER) to identify additional specific opportunities for using recycled materials in upcoming major infrastructure projects.

The GDA is a voluntary arrangement between state and local government regional bodies. The aim is to promote sustainable development goals (SDGs), in this instance SDG 12 - responsible consumption and production, and SDG 17 - partnerships for the goals. Parties that make an agreement commit to certain shared goals, monitoring these goals and implementing measures for achieving them. The agreement can be used as a steering instrument instead of legislation.

The GDA aims to accelerate the establishment of a local government and state government platform to provide a structured and efficient pathway towards increased resource recovery infrastructure in both the Perth/Peel region and in WA's south west.

EMRC CEO Marcus Geisler said, 'We are delighted to have Mindarie Regional Council and the Resource Recovery Group on board as our newest GDA members. Together our membership is looking forward to exploring some exciting and innovative infrastructure ideas for the benefit of all our communities.'

Mindarie Regional Council CEO Scott Cairns agrees. 'Alliances such as the GDA have the potential to drive the development of markets for recycled products in to the future. By working more closely together, state and local government partners are well-placed to advance the use of recoverable resources such as FOGO products for the benefit of communities across the state.'

Mr Geisler continued, 'Collaboration, collaboration and collaboration will deliver the Circular Economy outcomes we aspire to, including meaningful jobs and resilience of our communities and ecosystems.'

GDA Chair Andonis Missikos said, 'We welcome all regional councils on board as well as industry and community sector partners in an 'Alliance of All Parties', working together implementing our "TOWARDS 100" policy promise through achievement of our 2030 recovery targets.'

METRONET's Denny Avenue Level Crossing Removal project is the first OMTID-METRONET demonstration project using purposely sourced FOGO-derived materials and also represents a significant move towards the introduction of Circular Economy principles in state infrastructure projects.

4 East Rockingham Waste To Energy Facility Takes Shape

The half-billion dollar East Rockingham Waste To Energy (ERWTE) facility was the destination for a site visit by EMRC Councillors and Deputy Councillors on 10 February 2022.

Waste To Energy plants create fuel from household and commercial waste and the 10ha East Rockingham facility will play a role in sustainable waste management in WA. The East Rockingham facility will create around 50 jobs for the life of the project. Among many impressive features of the construction process is the use of one of the world's heaviest-lifting cranes – required to lift large steel beams and modular units into position.

The EMRC, one of the founding residual waste supply partners of the project, plans to send significant amounts of residual waste to the facility after its scheduled opening in November 2022. When fully operational, the ERWTE will generate 28.9mw/h, enough to power 36,000 Perth homes.

EMRC have negotiated a 'waste arising' supply contract on behalf of a number of it's member councils, which means ongoing flexibility, no locked in volumes and keeping open the opportunity for more resource recovery from the residual waste stream through collection and/or processing.

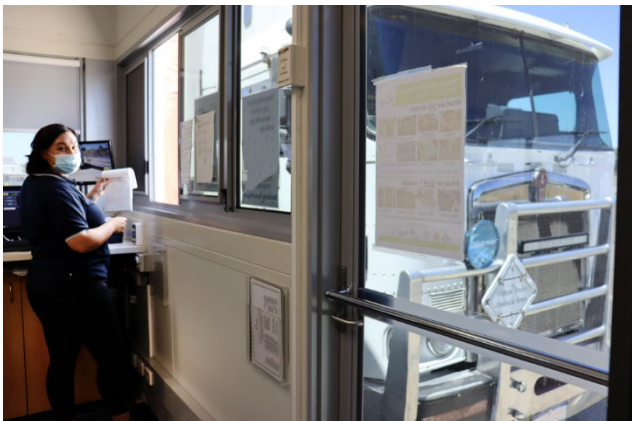

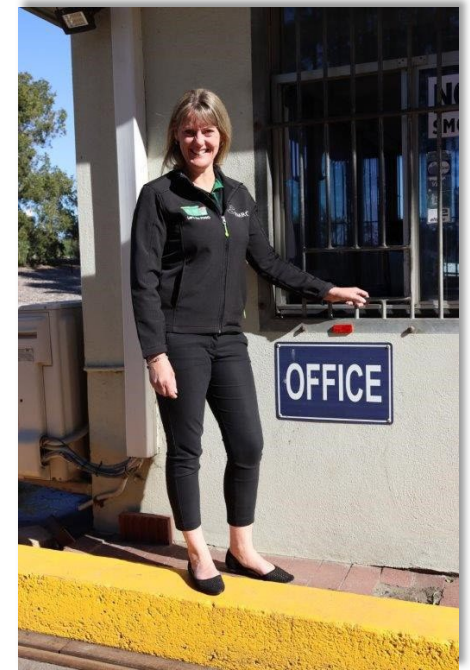
First impressions always count. And for many visitors welcomed to the EMRC's operational sites, their first impressions are provided by the Team Members at our weighbridges.

10 EMRC Launches Circular Economy Webinar Roadmap 2022

A Roadmap designed to increase awareness and catalyse the transition to a more Circular Economy in WA has been launched by the EMRC.

Part of a unique educational program created in collaboration with Circular Economy Western Australia (CEWA), the Roadmap is designed to benefit businesses and local governments in their approach to joining the Circular Economy revolution.

The Roadmap details nine webinars planned to run until November 2022. Each of the webinars will cover different aspects of how the move towards a Circular Economy will provide a boost to the regional economy and Perth's Eastern Region as a whole. The nine topics in the program will build a composite picture of how a Circular Economy works in practice and the educational aspect of the program will enable participants to start planning a move towards a Circular Economy. This will benefit organisations, state government agencies, local governments, communities and EMRC stakeholders

The first webinar on Friday, 25 February 2022, titled 'What Is A Circular Economy?', provided participants with an opportunity to understand the principles of a Circular Economy and set out a practical approach to change existing thinking. The webinar featured a case study of [Orange Tractor](#), an award-winning organic vineyard based near Albany in WA's south west.

Topics covered in the other eight successive webinars, which are closely aligned to the EMRC's recently-launched Sustainability Strategy, will include minimising food waste, embracing circularity in the home, local government procurement in a Circular Economy, reducing biodiversity loss and paving the way towards Net Zero emissions.

EMRC CEO Marcus Geisler said, 'The Roadmap will take WA's business community on a journey towards a fully-understanding Circular Economy approach.

'The launch event begins the process of gaining practical skills and knowledge to start making the transition. "Think forward, act now" and get involved to see for yourself how the Circular Economy can make a difference.'
