5.1 DRAFT WA WASTE STRATEGY 2030

The Director Waste Services and Ms Gae Synnott from Synnott Mulholland provided an overview of the Draft Waste Strategy 2030, Western Australia's Waste Strategy.

Tabled:

Draft WA Waste Strategy 2030

Ms Synnott invited the group to discuss and provide feedback on the Draft Waste Strategy 2030 (Draft Strategy) and the following points were raised and discussed:

- Forums were held for everyone to attend earlier in the year and the EMRC attended a forum and provided a submission;
- The EMRC and WALGA will respond to the Draft Strategy;
- The Draft Strategy gives a broad overview of where the state is going and where we are aligned;
- The five (5) Key Result Areas of the Draft EMRC Regional Communications and Support Strategy are aligned with the Waste Strategy 2030 and how it will drive future decision making;
- There are no noticeable timelines of when the action plan will be implemented:
- How are we going to achieve the objectives?
- Illegal dumping target should be zero, not a move towards zero;
- Targets will be unachievable if there is no mention of how the strategy is going to achieve the target;
- What are the Key Performance Indicators for achievement of the objectives?
- There is a greater focus on the community to take action and be responsible;
- Comments from the members were noted for the EMRC to include in their submission. Submissions close 5:00pm Tuesday 6 November 2018; and
- Individual members were invited to provide the EMRC with further comments on the Draft Strategy prior to Tuesday 31 October 2018.

5.2 DRAFT EMRC REGIONAL WASTE COMMUNICATION AND SUPPORT STRATEGY

Ms Synnott provided a presentation and update on the progress of the Draft EMRC Regional Waste Communication and Support Strategy (Draft EMRC Strategy). Detailed information was provided about the following six (6) Key Result Areas and Key Element messages of the Draft EMRC Strategy:

 - c. Is setting an example (e.g. Council procurement) sufficient or is more needed to encourage action?
 - d. What information should be communicated about waste performance?

Waste Education Report - May 2018 to September 2018

This report is provided to the member Council representatives on the Regional Waste Education Steering Group (RWESG), members of the Waste Management Community Reference Group (WMCRG) and members of the Executive Management team. This report includes data from May 2018 to September 2018 (period). The period since the last WMCRG.

1. Public Recycling Updates

The EMRC collected 16.39 tonnes of household batteries and 1.49 tonnes of CFL's from within our region in the 2017/2018 financial year.

1.1 Public Place Battery Collection Program

- Our Battery Collection Officer has been streamlining operations at the Red Hill Waste Management Facility to ensure the batteries and CFL's are handled, sorted, stored and prepared for transportation appropriately.
- We sought clarification from WALGA and Toxfree on a number of issues, which have been responded to and distributed to all regional councils.
- One recycling station was adapted to fit 6 volt batteries, so that the current stations could be multi-purposed to accept: batteries, CFL's and mobile phones. This unit is being trialled at Hawaiian's Forrestfield (shopping centre), in response to a request from the shop owner who manages this location.
- The City of Bayswater commissioned and delivered new recycling stations to four (4) new locations in July 2018. These are: Bayswater Waves, Morley Galleria, Hawaiian's Noranda and the Morley Recreation Centre.

1.2 Schools Battery Collection Program

- Due to the rostering and the number of schools in the program, schools in each Council region are not collected each month, however they are scheduled for collection at a minimum of once per semester, with additional collections available on request if needed.
- School data was finalised for the Schools Battery Collection Program's annual competition; with Chidlow Primary School (219.4 kg) winning the small school category, Darlington Primary School (337.3 kg) winning the medium school category and High Wycombe Primary School (588.6 kg) winning the large school category. The most improved school winner was Greenmount Primary School.
- Commencing in 2019, the Schools Battery Collection Competition will change to align with the calendar year instead of the financial year. This has been implemented to increase ease of administrating the program, decreasing quantities of batteries left in schools over the summer holidays, and potentially reduce costs. Thirty-six schools not yet registered for the program were contacted via mail inviting them to join. Prizes awarded at the end of the shorter six-month competition (July December 2018) will include a 'most-improved' recipient in each school category plus a prize category exclusively for recently joined schools.
- New Schools joining the program in July 2018 included: South East Metro Language Development Centre (260 students), Ellenbrook Secondary College (1681 students), Aveley Primary School (732 students), Morley Senior High School (1,055 students) and Maylands Peninsula Primary School (651 students).

4. Additional Current projects:

4.1 Waste and Recycle Guides 2018/2019

- Guide production ran behind schedule this year, with a number of councils having to wait on Council decisions therefore putting their guides on hold until the information needed was available.
- It is important that the guide timeframes are kept in member Councils minds as they do their Financial Year planning if guides are to be received in time.
- There have been issues with several guides this year and new measures will be implemented to minimise problems next year.
- Discussions are underway regarding an online platform to complement the paper version of the guide.

4.2 Earth Carers Courses

- This May Earth Carers course attracted a maximum of 40 registrations. On average, 25 people attended each session and 9 participants completed all five sessions. Those who completed the whole course received a certificate, t-shirt, reusable bag and produce bags. Participants who missed one or more of the sessions will be invited to attend those sessions when the course is next held in November 2018.
 - The five Earth Carers sessions covered the following:
 - A tour of the City of Swan Operations Depot;
 - Waste on individual and regional scales;
 - Tour of the Red Hill Waste Management Facility;
 - Trip to the Wasteless Pantry;
 - Green cleaning workshop;
 - Make your own personal body care products;
 - Zero-waste living principles;
 - Organics workshop composting, worm farming and bokashi;
 - Recycling in the region guest speaker from Cleanaway; and
 - The Hazelmere Resource Recovery Park.



• The next course is scheduled from 7 - 21 November 2018. Expressions of Interest were open via the RGang website in May 2018 and registrations for the November course opened on 18 September 2018, with 20 people registered as of the end of September. Participants of the May 2018 course who missed one or more sessions have been invited to complete those sessions which will enable them to graduate from the course.

4.3 Youth Waste Workshops

- Waste Education and Bush Skills 4 Youth have collaborated to create two full day workshops to be run through the school holidays.
- Both workshops will explore what happens with waste in the eastern metropolitan area including;
 - o Its environmental effects;
 - o What individuals and their families can do; and
 - Protecting our communities, waterways and animals.
- The July workshop was targeted at 7-12 year old children and was attended by more than 40 people. The workshop
 included a focus on Plastic Free July, links between waste and the environment, food waste and waste minimisation
 on a household level.
- The second workshop, for children 12-18 years old was planned for 27 September 2018 and was to incorporate the themes of fast fashion, e-waste, consumerism, and inspiring participants to enact change in their communities. Due to insufficient registrations, this workshop was postponed until further notice. Of all the waste education we conduct with young people, the teen-age bracket is by far the most difficult to engage. However, we believe this demographic can be captured, and the facilitators will review the format of the planned workshop before it is rescheduled.

4.4 Red Hill Waste Education Building and Garden

- The garden has been pruned, tidied and fertilised with worm castings.
- The worm farm has been totally revamped, dealing with the enormous bush cockroach infestation.
- Temporary signage has been added to the worm farm and compost bin to educate users and visitors.
- Monitoring and upkeep of the worm farm and compost bin have continued to ensure that these can be used for education purposes when required.
- The worm farm and compost bin are now functioning well and are providing additional learning activities.
- The rear landing of the Waste Education Building required repair due to the presence of protruding nails and loose decking.
- The layout in the Education Centre has been modified to improve the appearance and functionality of activities.
- The "Are You a Smart Shopper' activity's signs have been replaced.
- The activity booklet has been reviewed and updated with a view to improve learning outcomes.
- More focus has been given to worm farming and composting activities as the Waste Education team works toward limiting the amount of craft activities, due to being time-consuming to set up, facilitate and tidy-up, and inevitably contribute to waste generation.

4.5 Waste Education Strategy

- EMRC is in the process of updating the Draft EMRC Regional Waste Communication and Support Strategy (EMRC Strategy). Waste Education has been involved and is working with the various stakeholders. RWESG is pending to finalise the Regional Waste Education Strategy, to ensure it is correctly aligned with the EMRC and WA Waste Strategy's. Reviewing time frames can then come in line with reviews of the State Strategy in the future.
- Once the EMRC Strategy and WA Waste Strategy is nearing completion, a dedicated meeting will be held to go over the draft Regional Waste Education Strategy and Action Plans thoroughly and adjust where needed.

4.6 Consistent Communication – Recycling Bin agreement

- A letter dated 26 June 2018 has been distributed from the three main Material Recycling Facility (MRF) operators in Perth. A common list of what can be included or should be excluded, from the recycling bin, has been agreed upon. This list has received a lot of publicity on TV, radio and social media.
- However it appears that the clients of the MRFs were not consulted and a number of our member Councils (MC) are now getting a large amount of enquiries.
- WALGA suggests that member Councils negotiate with the MRF operators as contracts are in place and this
 document came out after Waste & Recycling Guides were distributed. The guide contents were approved by the
 MRFs before going to print. In addition there may be financial costs to member Councils due to these MRF changes.



- Several of the MRF operators who have signed the letter have since said that it is not the final list and is still
 undergoing changes.
- This list is something waste educators in Perth and a number of waste groups have been pushing for over many years
 and is a positive step forward, however the lack of communication with stakeholders, timing and reasons have been
 questioned.
- This list does conflict with several messages that have been communicated over past years, especially the recyclability of aerosol cans.
- The list and the high level of media exposure it has been given is causing a number of problems, that will take some time to sort out and has resulted in many confused recyclers in the community.

4.7 Recycling Market Update and Consistent Communications Information

- A number of briefing sessions and meetings have been held over the recycling market and move towards consistent communications.
- The market is changing rapidly and is uncertain for a number of materials.
- There are a range of different materials which cause problems when put in a recycling bin and these issues can affect processing, safety or quality.
- A consistent message has been agreed upon, and Local Governments are encouraged to implement this messaging as soon as practicable.
- Discussion at information sessions has also covered specific questions about why different material types could not be recycled through the kerbside bin. It is important for this information to be clearly communicated to the community about why certain messages have changed and why behaviour needs to change.
- Unfortunately the timing of this announcement regarding consistency has been declared after Local Government budgets have been set and educational materials, such as the Waste and Recycle (W&R) Guides, have been distributed for the year. The updated list has been dictated by the change in market conditions, and it is acknowledged that the timing does not fit into Local Government budget cycles. This is a long term issue and education material will need to change progressively over time. All MRF operators will provide updated education material for their customers.
- There are immediate, medium and long term actions to be implemented by a range of stakeholders to address this
 issue.

4.8 Website, Fact Sheets and Brochures

- Colouring-in sheets with information relating to each of the RGang messages (Reduce, Reuse. Recycle and Recover) were produced upon request from the City of Bayswater, and are available for distribution to all member Councils.
- The RGang website has been reviewed in depth and pages have been updated offering registrations to upcoming events..
- Correct versions of all W&R Guides are now online. Pages are being updated and condensed as time allows, with a number of old pages removed and new pages created.
