#### **PURPOSE OF REPORT**

The purpose of this report is to provide Council with an overview of the EMRC's financial performance for the period ended 30 November 2024.

#### **KEY POINT(S)**

- Significant year to date budget variances greater than 10% or \$20,000, whichever is the greater, within each nature and type category on the Statement of Comprehensive Income as of 30 November 2024 have been identified and are reported on in the body of the report.
- The Financial Reports are unaudited and may be subject to amendment as a result of any audit adjustments.

#### **RECOMMENDATION(S)**

That Council receives the Statement of Comprehensive Income, Capital Expenditure Statement, Statement of Financial Position, Statement of Cash and Investments, Statement of Financial Activity and the Investment Report for the period ended 30 November 2024.

#### SOURCE OF REPORT

Chief Financial Officer

#### **BACKGROUND**

- 1 It is a requirement of the *Local Government (Financial Management) Regulations* 1996 (r.34) that a Local Government is to prepare and present to Council financial reports in such a form as the Local Government considers to be appropriate.
- Submitted to each meeting of Council is a financial report and summaries which provide an overview of the year to date budget performance for operating activities and capital works. Variances greater than 10% or \$20,000, whichever is the greater, within each nature and type category on the Statement of Comprehensive Income are reported on in the body of the report. Also included are end of year forecasts by nature and type for operating activities and end of year forecasts for each capital works project. These forecasts are reviewed regularly in order to provide an accurate forecast of the end of year result.

#### **REPORT**

Outlined below are financial statements for the period ended 30 November 2024. Where possible the year to date monthly budget allocations will be reviewed in order to match the appropriate timing for the various projects budgeted to be undertaken. This will provide a better comparison between the year to date actual and year to date budget figures.



#### Statement of Comprehensive Income - Nature and Type (refer Attachment 1)

The net operating result as of 30 November 2024 is a favourable variance of \$232,339 (5.37%) against budget. The following information is provided on key aspects of Council's year to date financial performance:

#### **Operating Income Variances Previously Reported to Council**

- Net User Charges of \$14,221,214 is below the budget by \$2,282,849 (13.83%). The variance is attributed to lower Class IV tonnages received than anticipated.
- Interest on Municipal Cash Investments of \$1,130,511 is above the budget by \$1,062,781 (1,569,14%) due to the higher investment rate achieved (4.96% average interest vs 4.43% budgeted) and higher available funds for investments.
- Reimbursement is above the budget by \$111,275 (13.01%). The major variances relate to an insurance reimbursement payout of \$124,740 for the Plant and an insurance reimbursement for repairs totalling \$50,340 for the Plant.
- Other Income of \$2,040,576 is above the budget by \$679,570 (49.93%) primarily due to an additional revenue generated from Australian carbon credit units (ACCU).

#### Operating Income Variances not previously reported to Council

9 Secondary Waste Charge is below the budget by \$130,421 (17.40%). Following the resolution of the council meeting on 22 August 2024, the Secondary Waste Charge has been temporarily suspended from 1 September 2024 until the end of the 2024/2025 financial year as a result the Secondary Waste Charge is below the budget.



There were no further significant Operating Income variances as of 30 November 2024.

#### **Operating Expenditure Variances Previously Reported to Council**

- 11 Contract Expenses is \$395,767 (10.24%) lower than the budget. The variance is attributed to lower consulting fees spent in Environmental Licensing and Waste Compliance and lower contract material and labour expenses spent in the Hazelmere Waste Transfer Station operations, compared to the budgeted amounts.
- Material Expenses of \$696,514 is \$117,866 (14.47%) lower than budget of \$814,380 due to the timing of various projects from different business units. Areas where the expenditures are lower than budget for various business units include the Office of the CEO (\$51,231), Business Support (\$40,483), Sustainability (\$20,081) and Operations (\$6,071).
- 13 Utility Expenses is \$36,401 (17.43%) below the budget of \$208,900. The major various is due to lower costs of water consumption and service charges for Hazelmere Resource Recovery Park.
- Fuel Expenses of \$677,599 is \$148,321 (17.96%) below the budget. The variance is attributed to lower purchase price of diesel fuel compared to budget.
- Insurance Expenses is \$125,599 (49.61%) above the budget of \$253,175 due to adjustment charges received for insurance premium for Waste Transfer Station from previous financial year.
- Miscellaneous Expenses is below the budget by \$403,251 (33.74%) due to the timing of variance projects from different business units. Areas where the expenditures are lower than budget for various business units include Business Support (\$68,649), Sustainability (\$45,696), the Office of the CEO of (\$10,420) and Operations (\$278,486).
- Provision Expenses is \$409,528 (168.37%) above the budget of \$243,230. This non-cash flow is related to Post Closure Site Rehabilitation and Environmental Monitoring provisions. The variance is attributed to the delay in East Rockingham Waste to Energy project and additional Class III tonnages received from member Councils, commercial and non-member Councils.





#### **Red Hill Tonnages - Member Councils**







- Tonnages received from member Councils at Red Hill Waste Management Facility were 51,605 tonnes compared to the budget of 30,539 tonnes.
- This compared with 46,465 tonnes in the previous corresponding period. The main variance is due to additional FOGO tonnages received from Shire of Mundaring and City of Swan.



The additional tonnages were also received from member Councils due to the delay in the East Rockingham Waste to Energy project.






#### **PURPOSE OF REPORT**

The purpose of this report is to provide Council with an overview of the EMRC's financial performance for the period ended 31 December 2024.

# **KEY POINT(S)**

- Significant year to date budget variances greater than 10% or \$20,000, whichever is the greater, within each nature and type category on the Statement of Comprehensive Income as at 31 December 2024 have been identified and are reported on in the body of the report.
- The Financial Reports are unaudited and may be subject to amendments as a result of any audit adjustments.

#### SOURCE OF REPORT

#### **BACKGROUND**

- 1 It is a requirement of the *Local Government (Financial Management) Regulations* 1996 (r.34) that a Local Government is to prepare and present to Council financial reports in such a form as the Local Government considers to be appropriate.
- Submitted to each meeting of Council is a financial report and summaries which provide an overview of year to date budget performance for operating activities and capital works. Variances greater than 10% or \$20,000, whichever is the greater, within each nature and type category on the Statement of Comprehensive Income are reported on in the body of the report. Also included are end of year forecasts by nature and type for operating activities and end of year forecasts for each capital works project. These forecasts are reviewed regularly in order to provide an accurate forecast of the end of year result.

#### **REPORT**

Outlined below are financial statements for the period ended 31 December 2024. Where possible the year to date monthly budget allocations will be reviewed in order to match the appropriate timing for the various projects budgeted to be undertaken. This will provide a better comparison between the year to date actual and year to date budget figures.



### Statement of Comprehensive Income - Nature and Type (refer Attachment 1)

The net operating result as at 31 December 2024 is a favourable variance of \$1,545,724 (41.54%) against budget. The following information is provided on key aspects of Council's year to date financial performance:

# Operating Income Variances Previously Reported to Council


- Net User Charges of \$17,656,714 is below the budget by \$2,551,221 (12.62%). The variance is attributed to lower Class IV tonnages received than anticipated.
- Secondary Waste Charge is below the budget by \$192,088 (23.67%). Following the resolution of the council meeting on 22 August 2024, the Secondary Waste Charge has been temporarily suspended from 1 September 2024 until the end of the 2024/2025 financial year as a result the Secondary Waste Charge is below the budget.
- Interest on Municipal Cash Investments of \$1,238,554 is above the budget by \$1,157,278 (1,423.89%) due to the higher investment rate achieved (4.95% average interest vs 4.43% budgeted) and higher available funds for investments.
- Reimbursement is above the budget by \$139,677 (13.60%). The major variances relate to an insurance reimbursement payout of \$124,740 for the Plant and an insurance reimbursement for repairs totalling \$50,340 for the Plant.
- 9 Other Income of 2,212,950 is above the budget by \$638,934 (40.59%) primarily due to an additional revenue generated from Australian carbon credit units (ACCU).

# Operating Income Variances not previously reported to Council

- Interest on Restricted Cash Investments of \$793,114 is above the budget by \$134,416 (20.41%). The variance is attributed to movements in restricted reserves and a higher balance in Restricted Cash Investments.
- There were no further significant Operating Income variances as at 31 December 2024.

# Operating Expenditure Variances Previously Reported to Council

- 12 Contract Expenses is \$1,387,606 (24.24%) lower than the budget. The variance is due to lower consulting fees spent in Waste Environmental (\$219,686), lower contract material and labour expenses spent in Waste Transfer Station (\$753,289) and lower contract material and labour expenses spent in Waste Environmental (\$112,466) compared to the budgeted amounts.
- Material Expenses of \$817,936 is \$158,708 (16.25%) lower than budget of \$976,644 due to the timing of variance projects from different business units. Areas where the expenditures are lower than budget for various business units include the Office of the CEO (\$44,690), Business Support (\$54,364), Sustainability (\$20,148) and Operations (\$39,506).
- 14 Utility Expenses is \$35,254 (14.04%) below the budget of \$251,160. The major various is due to lower costs of water consumption and service charges for Hazelmere Resource Recovery Park.
- Fuel Expenses of \$794,227 is \$196,877 (19.86%) below the budget. The variance is attributed to lower purchase price of diesel fuel compared to budget.
- Insurance Expenses is \$124,259 (40.90%) above the budget of \$303,810 due to adjustment charges received for insurance premium for Waste Transfer Station from previous financial year.
- Miscellaneous Expenses is below the budget by \$564,908 (38.22%) due to the timing of variance projects from different business units. Areas where the expenditures are lower than budget for various business units include Business Support (\$95,672), Sustainability (\$43,347), the Office of the CEO of (\$25,554) and Operations (\$400,335).
- Provision Expenses is \$509,667 (174.62%) above the budget of \$291,876. This non-cash flow is related to Post Closure Site Rehabilitation and Environmental Monitoring provisions. The variance is attributed to the delay in East Rockingham Waste to Energy project and additional Class III tonnages received from member Council, commercial and non-member Council.

- The level of cash and investments in the Municipal Fund as at 31 December 2024 is \$15,673,305 and Restricted Cash amount to \$69,222,233.
- The net movement for the month is an increase of \$3,087,608.
- As end of year forecasts are yet to be reviewed, the forecast balances as at 31 December 2024 are as per the budget estimates.





# **Red Hill Tonnages - Member Councils**







Tonnages received from Member Councils at Red Hill Waste Management Facility were 61,336 tonnes compared to the budget of 33,953 tonnes.



- This compared with 54,575 tonnes in the previous corresponding period. The main variance is due to additional FOGO tonnages received from Shire of Mundaring and City of Swan.
- The additional tonnages were also received from member Councils due to the delay in the East Rockingham Waste to Energy project.

- Total Red Hill tonnages received from all sources were 163,672 tonnes compared to the budget of 141,744 tonnes. The current percentage between commercial customers and member Council is 62.52% and 37.48% respectively.



#### **PURPOSE OF REPORT**

The purpose of this report is to provide Council with an overview of the EMRC's financial performance for the period ended 31 January 2025.

#### **SOURCE OF REPORT**

#### **BACKGROUND**

- 1 It is a requirement of the *Local Government (Financial Management) Regulations* 1996 (r.34) that a Local Government is to prepare and present to Council financial reports in such a form as the Local Government considers to be appropriate.
- Submitted to each meeting of Council is a financial report and summaries which provide an overview of year to date budget performance for operating activities and capital works. Variances greater than 10% or \$20,000, whichever is the greater, within each nature and type category on the Statement of Comprehensive Income are reported on in the body of the report. Also included are end of year forecasts by nature and type for operating activities and end of year forecasts for each capital works project. These forecasts are reviewed regularly in order to provide an accurate forecast of the end of year result.

#### **REPORT**

Outlined below are financial statements for the period ended 31 January 2025. Where possible the year to date monthly budget allocations will be reviewed in order to match the appropriate timing for the various projects budgeted to be undertaken. # **Operating Income Variances Previously Reported to Council**

- Secondary Waste Charge is below the budget by \$253,755 (29.06%). Following the resolution of the council meeting on 22 August 2024, the Secondary Waste Charge has been temporarily suspended from 1 September 2024 until the end of the 2024/2025 financial year as a result the Secondary Waste Charge is below the budget.
- Interest on Municipal Cash Investments of \$1,344,805 is above the budget by \$1,249,983 (1,318.24%) due to the higher investment rate achieved (4.94% average interest vs 4.43% budgeted) and higher available funds for investments.
- 7 Interest on Restricted Cash Investments of \$1,028,954 is above the budget by \$260,473 (33.89%). The variance is attributed to a higher balance in Restricted Cash Investments.
- Reimbursement is above the budget by \$120,010 (10.02%). The major variances relate to an insurance reimbursement payout of \$124,740 for the Plant and an insurance reimbursement for repairs totalling \$50,340 for the Plant. This offset by the lower than budgeted reimbursement from the Operations of Mundaring transfer station.
- Other Income of 2,474,325 is above the budget by \$687,299 (38.46%) primarily due to an additional revenue generated from Australian carbon credit units (ACCU).
- There were no further significant Operating Income variances as at 31 January 2025.

# **Operating Expenditure Variances Previously Reported to Council**

- 11 Contract Expenses is \$1,057,581 (15.93%) lower than the budget. The variance is due to lower consulting fees spent in Waste Environmental (\$251,573) and lower contract material and labour expenses spent in Waste Transfer Station (\$785,516) compared to the budgeted amounts.
- Material Expenses of \$943,290 is \$215,138 (18.57%) lower than budget of \$1,158,428 due to the timing of variance projects from different business units. Areas where the expenditures are lower than budget for various business units include the Office of the CEO (\$68,919), Business Support (\$63,906), Sustainability (\$46,774) and Operations (\$35,539).
- 13 Utility Expenses is \$32,525 (11.10%) below the budget of \$292,940. The major various is due to lower costs of water consumption and service charges for Hazelmere Resource Recovery Park.
- Fuel Expenses of \$953,525 is \$202.763 (17.54%) below the budget. The variance is attributed to lower purchase price of diesel fuel compared to budget.
- Insurance Expenses is \$122,918 (34.68%) above the budget of \$354,445 due to adjustment charges received for insurance premium for Waste Transfer Station from previous financial year.
- Miscellaneous Expenses is below the budget by \$774,253 (45.16%). The primary variances pertain to the gate fee payments to East Rockingham Waste to Energy. The project delay has resulted in a delayed in gate fee payments.
- Provision Expenses is \$667,501 (196.02%) above the budget of \$340,522. This non-cash flow is related to Post Closure Site Rehabilitation and Environmental Monitoring provisions. The variance is attributed to the delay in East Rockingham Waste to Energy project. As a result, additional Class III tonnages received from member Council, commercial and non-member Council.





### **Red Hill Tonnages - Member Councils**







Tonnages received from Member Councils at Red Hill Waste Management Facility were 71,129 tonnes compared to the budget of 37,448 tonnes.






#### **BACKGROUND**

- The EMRC requires the supply and delivery of Alternative Daily Cover for Red Hill Waste Management Facility, 1094 Toodyay Road, Red Hill WA 6056.
- The use of Alternative Daily Cover reduces the use of clay for cover material, thus saving on landfill airspace.

#### **REPORT**

- RFT 2024-005 for the Supply of Alternative Daily Cover for Red Hill Waste Management Facility was issued via Tenderlink on 30 October 2024 and closed on 19 November 2024.
- 4 At the close of the Tender period only one tender submission had been received and was deemed compliant.
- 5 The following qualitive criteria formed part of the tender evaluation process:

- The balance of the weighting of 30% is based on the pricing criterion.
- 7 The schedule of rates submitted by Odour Control Systems International (Australia) Ltd is attached (Confidential Attachment 1).
- The evaluation process was completed independently by three EMRC officers, who found that Odour Control Systems International Ltd had demonstrated the required experience and WHS standards to deliver a high quality product.
- 9 Odour Control Systems International Ltd is therefore recommended as the preferred tenderer in accordance with the pricing schedule supplied.



- 6.1 REVIEW OF WASTE MANAGEMENT LEGISLATION ADVOCACY POSITION

#### MUNICIPAL WASTE ADVISORY COUNCIL MOTION

That the Municipal Waste Advisory Council recommends that State Council:

 Rescind the existing Waste Management Legislation Policy Statement and Advocacy Position 7.1:

Local Government supports waste management legislation that references the principles of Sustainability and the Waste Hierarchy.

To be effective, waste management legislation should include the following primary objectives:

- 1. Protection of human health and the natural environment;
- 2. Minimise resource consumption;
- 3. Minimise waste; and
- 4. Effect the transition to a waste free society.
- 2. Endorse a new Waste Management Legislation Advocacy Position:
  - 1. Local Government supports Australian and State Government Waste Management Legislation which:
    - a. Includes requirements for national and state Waste Strategies which support Local Governments to implement the Strategies and achieve targets
    - b. Focuses on coordinated action and clear roles and responsibilities
    - c. Establishes a lead agency for waste management
    - d. Establishes and maintains a regulated product stewardship framework for all products entering the Australian market

- e. Includes provisions to optimise market development and participation in waste processing.
- 2. Local Government calls for the Waste Avoidance and Resource Recovery Act 2007 to be amended to include:
  - a. Waste education in the definition of Waste Services
  - b. Circular Economy principles.

#### **Executive Summary**

- The <u>Waste Management Legislation Policy Statement</u> was adopted in 2004. The Statement outlines Local Government's position on waste management legislation in Western Australia and sets out the key objectives Waste Management legislation should achieve.
- WALGA used the Waste Management Policy Statement to inform advocacy on the development of the Waste Avoidance and Resource Recovery (WARR) Act 2007.
- The current Advocacy Position 7.1 Waste Management Legislation, and many of the elements in the Policy Statement, are no longer relevant as they have been achieved.
- The revised Advocacy Position focuses on both Australian and State Government legislation and reflects the shift in focus from traditional waste management toward a circular economy approach.

#### **Background**

WALGA used the Waste Management Legislation Policy Statement as a reference point in the development, and both reviews, of the *Waste Avoidance and Resource Recovery Act 2007* (WARR Act). There have not been any significant changes to the WARR Act. Since the development of the WARR Act, there has been a significant shift in thinking in relation to waste management, particularly with the advent of Circular Economy and the increased understanding of the importance of waste education and behaviour change.

The Recycling and Waste Reduction Act 2020 (RaWR Act) is in the process of being reviewed (see Item 8.4). The development of an updated Advocacy Position will assist in providing input to the review.

#### Comment

Local Government feedback identified key areas to include in the revised advocacy position, reflecting the shift in waste management approaches since the WARR Act was introduced. There is also the opportunity to expand the Advocacy Position ahead of the review of the RaWR Act.

The Advocacy Position focuses on the importance of Waste Strategies (at the national and state level), coordinated action, clear roles and responsibilities, a lead agency for waste management and an effective product stewardship provisions. Specifically, for the WARR Act, amendments are suggested to include waste education and circular economy principles.

Feedback from the OAG focused on ensuring that market participation in waste processing is optimised. The Advocacy Position has been updated to reflect the comment.

#### Discussion at the Municipal Waste Advisory Council meeting

The Council considered and endorsed the new Waste Management Legislation Advocacy Position.

#### 7 Discussion Items

#### 7.1 DRAFT CIRCULAR ECONOMY ADVOCACY POSITION

#### **Executive Summary**

- The development of a Circular Economy Advocacy Position was initially discussed at the April 2024 OAG and MWAC meetings, after being identified as a priority for 2024.
- WALGA's advocacy in relation to circular economy has identified that action is required from all levels of Government.
- The adoption of an Advocacy Position on Circular Economy is far broader than the
  waste management considerations and will be circulated for input from a range of
  areas within WALGA, following discussion at the OAG meeting.
- Consultation with Local Government on the Advocacy Position is planned for 2025.

#### For Discussion -Draft Advocacy Position

- 1. Local Government supports the principle of a circular economy and recognises its potential to maximise use of resources and reduce a range of environmental impacts associated with the manufacture, distribution and post consumption management of products.
- 2. Local Government supports circular initiatives through:
  - a. establishing circular procurement practices including use of recovered materials and investigation of alternative procurement models
  - b. supporting the implementation of reuse and repair initiatives
  - c. implementing community behaviour change programs to avoid waste generation and recover high value resources through Local Government collections
  - d. facilitation of resource recovery centres that allow residents to drop off a range of different materials
  - e. aligning Local Government activities with State and Australian Government circular economy frameworks.
- 3. Local Government calls on the State Government to:
  - a. undertake a detailed study to determine how Western Australia can move to a circular economy, including identifying any sectoral transition requirements
  - b. provide incentives for producers and processors to adopt circular practices
  - c. invest in research and market development for recovered materials and determine the barriers to market participation
  - d. remove legislative barriers to enable more circular approaches to procurement (such as leasing and hiring)
  - e. develop and fund community behaviour change programs to avoid waste generation and recover high value resources
  - f. support reuse and repair programs for the community, including incentives, training and cost-effective insurance options
  - g. embed circular procurement practices across Government

- h. establish a state-wide platform for businesses to list and collect inventory that could be reused or repurposed.
- 4. Local Government calls on the Australian Government to:
  - a. establish and maintain a regulated product stewardship framework for all products entering the Australian market
  - b. set material design standards to ensure products can be reused, repaired and recycled
  - c. include reuse and repair targets and data in the National Waste Policy
  - d. embed circular procurement practices across Government, including recycled content targets
  - e. support and provide incentives for recovered materials infrastructure and market development
  - f. work with State/Territory and Local Governments to fund community behaviour change programs to avoid waste generation and recover high value resources
  - g. implement Right to Repair Legislation, including incentives, training and cost-effective insurance options.

#### **Background**

Circular economy is defined as "an economic strategy that maintains the value of materials for as long as possible and ensures materials are used efficiently across all phases of their life cycle". WALGA's <u>Submissions</u> on the review of the State Waste Strategy identified that an overall State Government position on a circular economy for Western Australia is needed. The Submission recommended State Government, in consultation with Local Government, develops a position and plan for a circular economy in Western Australia which includes consideration of costs, benefits and options.

WALGA's <u>Submission</u> to the recent Productivity Commission Inquiry into Opportunities in the Circular Economy further highlighted priority action areas to promote circularity. This included the important role of procurement, the need for quality assurance and market development for recovered materials, specific programs and incentives to shift consumer behaviours, the Right to Repair and a mandated product stewardship framework.

A defined circular economy position and plan is required to back up the vision and identify the role of each sector in achieving a circular economy both nationally and in Western Australia. There has been only limited discussion outside of the waste management context on what a circular economy is and its potential.

Circular economy has the potential to bring significant benefits to Local Government in WA. However, detailed analysis of the circular economy in a WA, and Australian, context is required to understand and quantify the costs and benefits and options for moving to this approach. The work undertaken by <u>Green Industries South Australia</u> for example, included developing the case for circular economy for the State and has now progressed to driving the transition across multiple industries. The <u>NSW Circular Economy Policy</u> introduced in 2019 sets out eight focus areas for a whole of government approach to transitioning to a circular economy.

Discussion at the Officers Advisory Group highlighted the need to invest in market development and support repair options. The next stage in the development of this Advocacy Position, following consideration by MWAC, is to develop a short discussion paper to accompany the Position, for consideration by Local Government.

#### Discussion at the Municipal Waste Advisory Council meeting

The Council discussed the draft Advocacy Position and requested an emphasis on the barriers faced by Local Governments, particularly in regional areas, to develop circular economy initiatives. Additionally, the Council emphasised that transitioning to a more circular economy is a market issue, which will need economic, policy and legislative reform to progress.

#### 7.2 E-CIGARETTE COLLECTION STUDY

#### **Executive Summary**

- With funding from the Waste Authority, and in partnership with the City of Striling, WALGA undertook an E-Cigarette Collection Study (Collection Study). The Collection Study's aim was to understand the scope of products currently on the market, resource recovery options and nicotine content. The City of Stirling's Recycling Centre Balcatta hosted the drop off location from November 2023 to August 2024.
- Perth Chemical Specialists (PCS) were contracted to collect, dismantle and source resource recovery options for the e-cigarettes. Chem Centre then tested a range of different e-cigarettes for nicotine content.
- 3,250 e-cigarettes were collected, with 86 identified brands and 5 brands making up 90% of e-cigarettes (IGET, Gunnpod, HQD, WAKA and Vapengin).
- The Collection Study found that e-cigarettes are highly recoverable, with over 65% of the materials being recyclable and over 34% recoverable either through energy recovery or manufactured into a waste derived fuel.
- 32 e-cigarettes were tested for nicotine content, with all but one containing nicotine.
- While the Collection Study shows that e-cigarettes can be recycled/recovered, national product stewardship is needed to ensure clear and funded end of life pathway for these products. Until a national scheme is in place, State funded options are needed.

#### For discussion

 Advocacy options and key stakeholders to engage for short term amnesty collections and longer-term product stewardship arrangements for e-cigarettes.

#### **Background**

E-cigarettes have emerged as a problematic waste for Local Government as they are disposed of illegally in public places and through the kerbside bin system, which can cause fires in trucks and at waste management facilities. E-cigarette sale and use has grown rapidly in WA.

To better understand the resource recovery options for e-cigarettes, WALGA received funding from the Waste Authority to undertake a collection study of e-cigarettes. The Collection Study found that e-cigarettes are highly recoverable, with over 65% of the materials being recyclable and over 34% recoverable either through energy recovery or manufactured into a waste derived fuel.

Actions are needed in both the short and long term to address the issue:

- Short term: It is proposed that the State Government fund a short-term e-cigarette
  collection amnesty. The suggested approach is through a State Government funded
  approach to Pharmacies, through the Pharmacy Guild of Australia, to collect ecigarettes. The products collected would be recycled through existing contractors
  who assisted WALGA with the collection study.
- Long term: The State Government work with other jurisdictions, Local Government and the waste and pharmaceuticals industry to develop and implement a national product

stewardship scheme for e-cigarettes. WALGA considers that leveraging the existing Return Unwanted Medications Project (RUM Project) would be the optimal solution to allow consumer take back.

Following consideration by OAG, MWAC and DWER the Collection Study will be finalised and published.

#### Discussion at the Municipal Waste Advisory Council meeting

The Council discussed the various collection approaches and noted the restrictions on collection locations due to Department of Health's concerns regarding normalizing vape use.

#### 7.3 WASTE PROCESSING CONTINGENCY PLANNING\*\*\*

#### **Executive Summary**

- WALGA has consistently advocated for effective contingency planning for waste management, most recently as part of the review of the State Waste Strategy.
- Several recent issues have highlighted the challenges facing the sector and the limited options for processing of some materials.

#### For discussion

• Options for advocacy regarding contingency planning for waste management.

#### **Background**

Contingency Planning for waste management is an essential element of any contractual arrangement, at an individual Local Government level, and more broadly at a system level. WALGA has continued to advocate for effective contingency planning to be put in place, most recently as part of the input into the Draft State Waste Strategy.

The lack of contingency planning, for example in the wake of the Cleanaway Material Recovery Facility fire, were apparent and had significant impacts on resource recovery and costs for the sector.

Several recent examples, including processing challenges for the Bunbury Harvey Regional Council and energy recovery facility issues, have again identified the need to develop a clear strategy.

#### Discussion at the Municipal Waste Advisory Council meeting

The Council discussed the current challenges facing Local Government in relation to waste management and formulated a list of preliminary actions including:

- Waste Levy: The potential impact of an increased Waste Levy was discussed and the need to establish an emergency management fund was identified.
- Contingency Planning: The idea of pre-approval for emergency licenses and identifying suitable locations in advance was discussed, with an emphasis on a risk-based approach during emergencies. Local Government Emergency Management Plans were identified as one mechanism to assist, but contingency planning across the entire waste management sector is needed.
- Regional Councils: The current situation regarding Regional Councils was discussed. The benefits of collaboration between Local Government for some services was highlighted, however it was agreed that there is a need to revisit the current approach. The attached Waste Vision Paper outlines WALGA and MWAC's previous work on this topic.

WALGA will advance these discussions and may schedule a specific MWAC meeting in early 2025.

#### 8.3 REVIEW OF DWER WASTE EDUCATION

- The WasteSorted Community Engagement team at Department of Water and Environmental Regulation are undertaking a review of waste education across Western Australia, in response to the changing waste environment and upcoming new State Waste Strategy.
- The review will be undertaken over the next six months and involve consultation with Local Government and industry stakeholder groups and an external review of the WasteSorted program. The Review will develop recommendations for waste education across WA for the next 5-10 years.
- WALGA hosted a workshop at the November Consistent Communications
   Collective meeting, with DWER, to commence the Review process. More than 30
   Local Government and industry waste education representatives discussed the
   communication, education, tools and programs needed for the future and what
   improvements can be made to current programs.

#### 8.4 REVIEW OF RECYCLING AND WASTE REDUCTION ACT

- A <u>statutory review</u> of the *Recycling and Waste Reduction Act 2020* (RaWR Act) has commenced. The Review will provide a report to the Minister for the Environment within 6 months of commencement.
- This is the first review of the legislation and focuses on
  - The operation of the RaWR Act
  - The extent to which its objects have been achieved
- Making recommendations to improve the efficiency and impact of the RaWR act.
   Formal Submissions have yet to be called, and further information has been requested from the Department as to the timeframe and process for engagement.

#### 8.5 REVIEW OF LOCAL GOVERNMENT REPORTING REQUIREMENTS

- All Local Governments that provide waste services are required to report waste and recycling data to the Department of Water and Environmental Regulation (DWER). These requirements are through CEO Notices that are issued under Part 3A, regulation 18D of the Waste Avoidance and Resource Recovery Regulations 2008 (WARR Regulations).
- WALGA and Local Government were heavily engaged in the initial development of the reporting requirements. WALGA made a comprehensive <u>Submission</u> when consultation occurred in 2019.
- DWER is <u>consulting</u> on the revised CEO Notices, with submissions due 31 January 2025.
- Following discussion with the Officers Advisory Group, which highlighted some improvements needed, correspondence will be provided to DWER rather than a formal submission.

This Group has not met since the previous MWAC meeting.

#### 10 Other General Business

#### 10.1 QUEENSLAND FRUIT FLY (QFLY) OUTBREAK

The MWAC Chair raised that there has been an outbreak of the Qfly and there is now a quarantine zone in place effecting a number of Local Governments. Residents in the red quarantine zone are advised to remove all fruit and vegetables from Qfly host plants, including fallen produce, regardless of their maturity. Residents have also been advised not to place any fruit or vegetables, which Qfly hosts in the FOGO bin. This may necessitate more frequent general waste bin collections.

# VISION FOR WASTE MANAGEMENT

IN THE METROPOLITAN AREA





There is broad agreement in the Local Government sector that there is a need for change to how waste in the metropolitan area is governed. The change required includes a greater role for the State Government in providing an integrated waste management system, as well as the need for consolidation, improved governance and greater direction for Regional Councils.

The structures we currently have in place have delivered kerbside and verge collection services which are consistently well rated by the community. However if we are to reach the targets set in the Waste Strategy for municipal solid waste diversion from landfill (50% by 2015 and 65% by 2020) and provide the modern infrastructure needed to cope with projected waste generation, a more coordinated approach is needed.







#### Local Government Recommended Model for Waste Management in the Metropolitan Area

#### **Governance and Roles**

- → Greater role for the State Government, to include an independent and strengthened Waste Authority which will:
  - Coordinate research on technology
  - Coordinate public education
  - Develop a metropolitan wide statutory plan for waste management (with Regional Delivery Plans to be developed by Regional Councils) and
  - · Approve Regional Delivery Plans.
- → Regional Council Consolidation:
  - Reduce the number of Regional Councils from five to three
  - Regional Council Governance
  - Compulsory Local Government membership
  - Ability to operate on a commercial basis
  - Geographically based boundaries

#### **Integrated Waste Management System**

- → An integrated waste management system includes provision for all elements of the waste hierarchy, from waste avoidance to landfill
- An assessment of the validity of an aspirational 'zero waste' outcome is required
- Any integrated waste management system to include a range of approaches to funding the delivery of State Waste Strategy Targets, including direct funding through the Levy and Extended Producer Responsibility approaches and
- A review of the appropriateness of 'landfill diversion' as the best benchmark of performance is also required.





The Robson Review of Local Government in the metropolitan area had several recommendations in relation to waste management. To ensure the best outcomes for the community and the environment, a WALGA Working Group (including Regional Councils, the Forum of Regional Councils, the Waste Authority and Local Government members) has been established to put together an approach to improve waste management in the metropolitan area.





## VISION FOR WASTE MANAGEMENT IN THE METROPOLITAN AREA



This Paper has been developed based on discussions by the WALGA Working Group. The aim of the Paper is to identify a future governance structure for waste management in the metropolitan area which will facilitate the delivery of the State Waste Strategy targets in a timely and cost effective manner. The Paper also identifies the high degree of agreement between all of the Local and State Government entities who are most concerned with waste management.

Local Government and Regional Councils have invested heavily in providing waste management solutions for the community, and waste management collection services consistently rate well in surveys on services delivered by the sector. Regional Councils, on behalf of their members, have developed – or are developing – alternative waste treatment (AWT) options. These options are substantially more expensive than landfill and these costs are causing tensions within the Regional Councils and their member Local Governments.

The ability of individual Local Governments to withdraw from Regional Councils represents a significant risk to the ongoing financial viability of both AWT's and the Regional Councils, and this uncertainty will undoubtedly inhibit the development of further infrastructure whether it be a public private partnership, take and pay or other contractual approach.


Until relatively recently there has been a fairly limited role by State Government in waste management. The Western Australian Waste Strategy: 'Creating the Right Environment' was released in March 2012 and sets clear targets and direction for waste management in the municipal, commercial & industrial and construction & demolition waste streams. This is the first strategy to be developed, as a requirement, under the Waste Avoidance and Resource Recovery (WARR) Act 2007. The targets for municipal waste are 50% diversion from landfill by 2015 and 65% by 2020. As of 2012, the diversion rate, in the metropolitan area was 37%; with recovery rates for Local Governments varying from 15% to 55%.

This Strategy was developed by the Waste Authority – the statutory advisory body for waste management, also established under the *WARR Act 2007*. The Strategy has taken some time to develop, and preceding its development there was very little guidance from the State Government regarding expectations for waste management.

Regional Councils have developed various AWT facilities which are either managed by the Regional Councils or through an arrangement with a commercial operator. As these facilities were developed at different times, with limited oversight and coordination from State Government, coupled with varying Local Government constraints, the selected technologies, contractual approaches and risk profiles are markedly different. Local Government is of the opinion that there is now a greater expectation and role for State Government – through the Waste Authority – in waste management.

Until recently, waste was not really considered in the planning system; the Municipal Waste Advisory Council and Forum of Regional Councils have been driving forces in the ongoing activities to ensure that waste is included in future plans for the metropolitan area. Waste management services are sometimes referred to as 'essential services' which Local Governments deliver.

What this means is that the service should be "considered a priority in strategic planning and is ultimately protected from disruption from outside sources such as national and man-made disasters, market failures, economic pressures, community complaint and mismanagement".



# WHAT DOES SUCCESS LOOK LIKE?

Rather than just change for change's sake, we need to be very clear about the outcomes we are seeking from changes – particularly the metropolitan wide coordination of waste management – an alternative way to look at this would be, what does success look like?

Critical success factors identified by the Working Group included:

- Practical commitment to the Waste Hierarchy from the State Government
- → Improved waste diversion to meet State Waste Strategy Targets
- → Improvement in effective resource recovery
- → Implementation of Extended Producer Responsibility Schemes by the State and/or Federal Government
- → Cost effective service for ratepayers
- → Greater hypothecation of the Landfill Levy to provision of waste infrastructure and management
- Metropolitan wide coordination of waste management
- Certainty for the operating environment next five to 20 years to enable investment in infrastructure;
- → Utilisation of extensive Local Government expertise in this area
- Optimisation of existing infrastructure and resources
- → Standardisation of collection systems to maximise efficiency of service delivery and education
- → Avoidance of infrastructure and resources duplication and
- Ensuring Local Governments who have already invested in infrastructure to meet State Government targets are not disadvantaged by the changes.

To achieve these outcomes, Local Government must clearly determine where the sector is best placed to add value to waste management activities – and where the State Government should take the primary role and responsibility.

### State Government Role – what is the proper level of State Government control?

Local Government acknowledges and welcomes an increased level of State Government involvement in waste management and considers this would be best provided through an independent and strengthened Waste Authority.

Currently the Waste Authority, while being statutory in nature, is only an advisory body. This means the Authority has limited power to act and expend funds without reference to the Minister. In addition the Authority is housed within the Department of Environment and Conservation. This service arrangement is a cause of potential confusion and a perceived conflict of interest.

Local Government supports an independent and strengthened Waste Authority as a separate entity with sufficient statutory power to implement a metropolitan wide approach to waste management. To ensure the Waste Authority has sufficient access to Local Government and Regional Council expertise it is suggested that an independent Waste Authority establish Committees to provide a vehicle for engagement with the Regional Councils, Local Government and other relevant organisations. The Committee focusing on municipal waste would be a key mechanism for Regional Council and Local Government input into the direction and approaches used by the Waste Authority. To facilitate a partnership approach Local Government/Regional Councils and the Waste Authority should have equal representation on the Committee.

# State Government Role – what is the role of State Government in waste management?

The role of the independent Waste Authority would be, in part, to coordinate a metropolitan wide approach to waste. This would be achieved through the development of a metropolitan wide, statutory plan for waste management. This Plan would provide clear direction for the Regional Councils, who would be required to develop Regional Delivery Plans, identifying the actions necessary to meet the requirements of the metropolitan wide statutory plans. These plans would be approved by the Waste Authority to ensure the actions of the Regional Delivery Plan accords with the metropolitan statutory waste management plan.

The Authority would also be responsible for coordinating research on waste technology and public education, and policy development in consultation with stakeholders. Local Government does not see the role of the State Government to be the operation of waste management facilities or the MSW supply chain. Currently the expertise in these areas rests in Local Government and the private sector. The suggestion of the establishment of Committees, identified in the previous section, is to ensure this expertise is utilised.

### Regional Council Consolidation – how many Regional Councils do we need?

Regional Councils, and their member Local Governments, have multimillion dollar investments in waste processing. Changes to governance need to ensure that these investments are used wisely and to the benefit of the entire metropolitan area, but those communities that have invested still retain equitable ownership, involvement and benefit.

The current membership of Regional Councils has evolved over time and has resulted in a situation where member Councils are not necessarily in the same geographic area. Local Government contends that there is a need for a strong geographic basis for Regional Councils, and that the optimal configuration will take into account strategic and logistic considerations.

Local Government considers that a fewer number of Regional Councils, would be beneficial; the suggested approach is reduce the current five Regional Councils to three. These Regional Councils would be northern, southern and eastern areas.

Three Regional Councils are suggested to:

- ➢ Ensure involvement of communities which have provided
  the significant investment in the development of AWT
- → Provide for synergies between collection and treatment
- Retain the considerable skills sets and experience in the area and
- ➢ Ensure a smoother transition to a new structure, as the current structures and legal arrangements are complex.

This approach is suggested as it was considered that a straight transition from five Regional Councils to one could be a very complex operation and that three Regional Councils would ultimately ensure a better outcome.





# Regional Council Governance – what changes to the Governance of Regional Councils are needed?

The governing board of a Regional Council is currently made up of Councillors from its member Local Governments. The number of representatives from each member Local Government varies, dependent on the Regional Council establishment agreement. Elected members appointed to the Regional Councils possess varying degrees of knowledge regarding waste management which may not include an in depth technical and business understanding is necessary to oversee these multimillion dollar businesses.

An alternative approach is to include on Regional Councils an independent person(s) with relevant skills and expertise. However, given the significant investment of Local Governments in the facilities developed by Regional Councils, it is imperative that Local Government retain majority membership of the Regional Council.

Several options have been proposed, for example Council Controlled Organisations or Regional Subsidiaries. These options would require amendments to the Local Government Act, but would allow these entities to act in a commercial role, with elected member involvement, but based on the concept of a skills based Board. This would ensure that the relevant business skills were present on the Regional Council while maintaining the vital link to the community representation role. The appointment of members to the Board could be undertaken in a range of ways.

# Regional Council Scope – what services should the Regional Council provide?

Currently Regional Councils provide a range of services, with some focusing solely on waste management activities and others including a range of other service offerings, such as regional development. All services are intended to provide value to member Local Governments.

In examining the approach to Regional Councils the question has to be asked what services should these Regional Councils provide? Should the services, outside those directly related to waste management be curtailed? The approach recommended is that there are a range of mandatory waste management services that a Regional Council has to provide, and discretionary services that the Regional Council may provide at the request of their member Local Governments.

If the Regional Council has the capacity to provide other services, this is in line with a commercial 'fee for service' approach. It also adds value for their member Councils. Regional Councils do not have to provide those services themselves – opportunities should exist to contract to private industry at the discretion of the Regional Council.











# INTEGRATED WASTE MANAGEMENT SYSTEMS

The current waste management systems have evolved without significant State Government oversight, Regional Councils and Local Government have taken the lead.

The sector fully appreciates that is it desirable to have an enhanced level of coordination that is possible only if the State Government is more actively involved in this area. Local Government strongly supports integrated waste management systems to deliver environmentally sound, socially acceptable and economically prudent waste management outcomes. What this means in practice is the Government needs to show strong leadership by mandating the expectations for waste treatment options and investing in waste reduction and avoidance. The current State Waste Strategy targets are based on landfill avoidance, which gives no prioritisation of the diverse activities that lead to this diversion.

While giving consideration to metropolitan wide governance, aside from infrastructure, waste avoidance and reduction needs to be a cornerstone of the long term approach to waste management. Ultimately, the less waste generated, the less that needs to be managed. This approach clearly fits into making better decisions for waste.

There are a range of waste treatment options including composting (aerobic and anaerobic) and a suite of Waste to Energy technologies. It is however important to acknowledge that landfill will have a place in waste treatment for a considerable time. Given these settings, it is therefore recommended that an assessment of the validity of an aspirational 'zero waste' outcome is undertaken. For an integrated waste management system to operate effectively a range of funding mechanisms are needed. There are a range of potential approaches to funding, two options are direct funding through the WARR Levy (or other State Government funding) and using Extended Producer Responsibility Schemes to shift the burden of responsibility to producers.



# CONCLUSION

Change in the current governance of waste management in the metropolitan area is clearly needed. Local Government has been taking a leadership role in diverting waste from landfill and ensuring that if material goes to landfill the environmental and human health impacts are minimised. However, with a growing population, an increasingly complex waste stream and more expensive treatment options becoming the norm, there is a need for a higher level of informed State Government coordination, leadership on policy, best practice and support via long term funding commitments.

Local Government is seeking commitment from the State Government to establish new governance structures for waste management in the metropolitan area (based on the model outlined) and put in place the policy, statutory and regulatory environment to ensure an integrated approach to waste management can be achieved for Western Australia.
